- 1. ORGANIZATION The Event is organized by abe advanced business events, a limited company with a stated capital of 50.000 Euros, whose registered head office is located at 35/37 rue des Abondances - 92513 BOULOGNE-CEDEX - France, hereafter referred to as the Organizer.
- 2. PURPOSE These regulations stipulate the terms and conditions according to which the Organizer sets up and runs the Event. They detail the respective rights and obligations of the Organizer and the signing company, hereafter referred to as the Participant. The Participant formally undertakes to abide by these regulations.
- 3. PLACE AND DATE The Event will be held at the Place and dates indicated here above. - 4/ REGISTRATION, CANCELLATION, PAYMENT Any company or institution is allowed to attend the Event provided it has the relevant skills to enter into negotiations with other attendees. The Organizer reserves the right to deny any registration without any obligations to justify their decision.
  - Receipt by advanced business events of the client's Order Form (Commitment to Participate), duly completed and signed, makes the entire service due for payment.
  - In the event of cancellation, the client is required to inform advanced business events by registered letter with acknowledgment of receipt at the following address: abe - advanced business events

The Place is the sole legal responsible for the facility and premises, permanent or temporary, used for the Event, as well as all companies and activities operating and running under their direct request. The Participant must hold an insurance policy that covers all damages caused by them, their staff or their belongings to a third party. The Participant must hold an insurance policy that covers all damages caused to their equipment and materials brought to the Event.
- 8. APPLICABLE AMENDMENTS The Organizer reserves the right to bring additional amendments to this agreement to deal with any matters not initially mentioned in the agreement. Such amendments shall be notified and diligently sent to the Participant and come into force immediately. Any infringement of this agreement by the Participant can lead to their expulsion from the Event provided the Organizer explicitly notifies it. In this case no refund or compensation of any kind shall be due to the Participant.
